## **Bylaws 1 - 9 Explained**



Hello Brothers and Sisters of Oregon. In this edition, we will be reporting on everything that happened at the 2025 State Convention. Before I get to my part, I want to say that we made history at this convention! I am proud to say that we as a body attended a "Hands Off" rally in Medford with all delegates as part of our convention! But I will let Brother Casey English tell you all about it. Overall, we had a smooth and fun convention. Medford did a wonderful job with all the work they put into this convention, so, Thank You Medford!



make it a combined position, and make the Assistant Secretary the Recording Secretary passed with no amendments.

Bylaw proposal #4 passed as printed. The reason for this one was to re-word this bylaw so we can hopefully keep the education fund. In the past, National has approved this bylaw, but told us we need to change it, or they will revoke the approval as it violates a few clauses in our constitution. With this change, we think that it should pass, and we will be good to keep an

education fund for aiding branches to attend future training. Bylaw proposal #5 passed as printed. This was to take out a few words that were not constitutional.

Bylaw proposal #9 passed as printed. This one was SU-PER IMPORTANT!! For the last 2 years, the only reason we were able to conduct business by having a quorum, was because the state board has a few members from small branches on it. If it weren't for the board having these delegates, this year we would have only had nine branches and could not conduct any business. So, we lowered the number of branches needed to attend and doubled the number of delegates needed. It's now seven branches and fifty delegates to make a quorum.

Sister Theresa Kauffman will report on the rest of the proposed bylaw changes. Take Care Everyone!

Ok, onto the proposed bylaw changes report. I will start by saying that all our bylaw proposals passed as well as the postponed bylaw from last year. Please refer to the last satchel for all the language of the bylaws as I only have five hundred words to report on this. A lot of these are fixes to existing bylaws as we will, over the next few years, clean up the language of our bylaws and make especially significant changes to help the state run smoother.

The postponed bylaw from 2024 passed with the amendment of the first bold sentence changing it to: The dues of this Association shall be equal to 1 hour of top pay of the non-technician Letter Carrier pay scale per annum.

Bylaw proposals #1-3 & #6-8 that merge the positions of Treasurer and Secretary into 1 Secretary-Treasurer position, change the language throughout the bylaws to



We also chose to use living plants as the centerpieces for the banquet so that they could be taken home and planted, which also helps the environment. We hope you enjoyed what we put together for you.

Is your branch thinking of hosting a convention in the future? Here is some information that might help you consider being a host branch. Hosting the state convention can seem like a daunting task, but with early planning and teamwork, it's entirely manageable. The best thing you can do is to start planning as soon as possible. Establish a timeline, create checklists, and assign tasks as much as possible. Staying organized will help you stay on track and reduce last-minute stress.

Finding the perfect venue is crucial. This is your first task! You will need to consider factors such as room availability, capacity, and food options. As a general estimate, plan for approximately 125 people. (call the State Board for the current estimate at the time of your planning)

A well-chosen theme can tie the event together and set the tone for the convention. The theme will guide decisions for decorations, your convention book, and even help to plan your fun night event. Every convention benefits from a bit of levity. Plan a fun night activity that encourages networking and relaxation. This could be anything from a themed dinner to a game night, a local sightseeing tour, or a comedian. To offset the costs of hosting, sell advertisements for

tion book. Local businesses and organizations often see value in reaching your audience. Get donations from local businesses. These things can significantly reduce expenses, and if you do enough of this,



you could cover all your cost and then some! Do this early!! Be sure to prioritize your spending on elements that will have the greatest impact on the experience.

You don't have to do it all on your own. Your State Board is an excellent resource for advice and information. They can provide guidance, support, and connect you with other hosts who can share their insights. If you call me, I can give you our experience as the host branch of 2025.

Don't be afraid that it's too hard or too expensive. You can do it!


## **Rally Time**

signing of a piece of paper they could nullify our contract which would take away our benefits and job security. We cannot let this happen when we are in solidarity.



The Letter Carrier of the Year Award was established in 1988 by the Oregon State Association board of officers. The first presentation of this award was made at the 1989 State Convention to Lannie Bogenoff of Branch 1433, Medford and has been a continued valued tradition since. Thirty-six years of presentations of this award have been given to Letter Carriers in special recognition and deep appreciation of commitments, contributions and friend-ship to fellow Letter Carriers, the community, and the Oregon State Association. Does someone you know exemplify these

qualities and do you think they should be recognized?

Does someone you know go above and beyond in community services and volunteerism? Here is how the process begins and how to nomsomeone: inate A detailed letter is written on why this person should be nominated for Letter Carrier of Year. This the letter should include all aspects of their contributions to the NALC, their fellow letter carriers, and their

community involvement. Then mail the letter to the Chair of the three-person committee by March 1st, before the State Convention to be read over with all the other submissions. The committee selects one nominee, and it is held in secret until the announcement is made at the Oregon State Convention Banquet dinner.

Before the announcement of the new nominee, all prior Letter Carrier of the Year names are read off by the Chair of the committee and anyone on the list in attendance is asked to come and stand in front of the stage until the new recipient is revealed. After all the names have been read, the Chair then begins to read "the letter" about the person about

## On State Speakers




Hello everyone, My article is a brief narrative on the State convention speakers

Tonya Graham the mayor of Ashland welcomed the convention goers and painted a portrait of the city. She put on offer some of the things Ashland was famous for (Shakespeare, Rogue Valley, Wine & Brewing) and discussed what was on offer this weekend. She ended her welcome with a story from her youth: how important the Post office had been

and how central it was to rural small-town living, well that and the chaos your brother ordering ten goslings can cause.

Graham Trainor President of Oregon AFL-CIO gave a Fiery and impassioned speech about moving the ball in Oregon. He told us that unionism growth in Oregon was the third highest in the nation. Emphasizing Oregon AFL-CIOs fight for Unemployment Insurance and combating workplace violence. He also emphasized the elevated level of support from workers under thirty, saying nearly 9/10 support unionism. Jeremy Schilling the President of Southern Oregon APWU, who multiple convention goers told this writer he bears more than a passing resemblance to, took a different approach as a guest speaker. He echoed what Graham Trainor said, these were trying times, but also, he sang. He taught us the song of his people. Having collaborated with women's groups in Southern Oregon, he showed off





ior Therapy, useful for winding through long careers filled with stressful situations both at work and home.

James Frankford made a request at the convention for more RAAs (Regional Administrative Assistants) for region two. Explaining there has been a huge explosion of DRT cases (from a low of 8800 to over 27000!). Regional needs to form new backlog teams and joint statement on violence Teams. He spoke on Covert Observations that members of management perpetuated over the last six months.

Cases of unannounced and unidentified observations taking place across region two. James also spoke on the impasse of S&DCs, not completely shuttered as some are still in the works (Eugene). Lastly, of course, John Beaumont spoke on the state of the good fight to lobby congress for our survival.

He talked about the very real threat of Privatization and the Post office being placed under the direction of the Dept of Commerce, the importance of congress and enacted legislation, and the constitutional necessity of the Post Office. He informed us of the three biggest attacks against NALC interests: CO-LAs, Workers & Retirees, and ending vote-by-mail.

## Bylaws 10 - 16 Explained




Hello folks! I hope everyone is doing well. Here are bylaws 10-16! This bylaw has to do with registration for delegates and the state host branch and how we register and send payments. Most of this is staying the same but it must be mentioned because it also changes the names of the officers to reflect the changes we voted on at state. So, it will now say State Secretary and State Treasurer. Bylaws #11, # 13, #16 have to do with

who our delegate at large positions are. We wanted to make sure we have alternate delegates if the president or vice president can't make it to state or national convention. Having two sets of delegates is very expensive so we wrote the following bylaws.

- 11. This bylaw discusses our elections and when they will take place and that we will elect to alternate delegates at large for conventions just in case the president or vice president cannot attend.
- 12. This bylaw simply says officers of this association shall be elected to hold office for a term of (2) years or

until a successor is appointed or elected.



14. Almost identical to bylaw #12 where it says a successor must be appointed or elected except bylaw #14 applies to the executive board.

15. We also voted to give executive board members five days to conduct their duties instead of two. We also voted to make the compensation grade 1 level O letter carrier pay.

16. The President shall be our only paid delegate at large. So, we will have two elected "backup" delegates, but the President and Vice President are our "main" delegates at large but the President is the only delegate who will be paid. I hope this brief explanation has been helpful and thank you to everyone who helped us vote and make it happen.




